## City of Costa Mesa COVID-19 Rental Assistance Program

## ELIGIBILITY

- Family with minor child in their custody
- Reside in the City of Costa Mesa and have a current rental agreement
- o Must have experienced a reduction or loss of income due to COVID-19
- Meet low-income requirements
- o Not receive any other form of rental subsidy or assistance
- Current on rent as of March 31, 2020

#### **Application Process**

- Submit a profile form on the <u>SPIN website</u> or call the mainline, 714-751-1101, and leave a message
- Complete screening. If eligible, complete an application and provide the supporting documents requested

### **Documentation**

- SPIN GAPP Application
- Explicit proof of income loss as a result of COVID-19
- o 3 most recent paystubs
- Proof of any other income (CalWORKs, Unemployment, Disability etc.)
- "Other Assistance" Affidavit
- o Current lease
- Ledger from property verifying rent is current as of March 31, 2020
- I.D. for each adult in the household
- Social Security Cards for each member of the household
- o 3 most recent bank statements

# DO YOU NEED HELP WITH FINDING HOUSING AND RENT?

If you live in or have connections to the city of Costa Mesa and have at least one minor child, you could be eligible for move-in and rental assistance.

# TO QUALIFY:

- Must have at least 1 minor age child
- Have ties to the city of Costa Mesa
- Be literally homeless or at-risk of homelessness
- Document ready for eligibility purposes

- Case management and housing navigation
- Access to employment and counseling services
- Financial assistance


