The presentation covered the increasing PERS contribution rates due to the reduction in head count and decreased investment returns. **NEW BUSINESS** 

Mr. Taboada gave a presentation to the committee covering the Costa Mesa Fire pension fund. The committee was briefed on the retroactive changes in compensation, the side fund, the underfunded status at entry in the risk pool, and the structure and composition of the pool. Mr. Hutchins was unable to present a review of the retiree medical plan and the item has been rescheduled for May 22, 2013.

**OPEN DISCUSSION** 

Mr. Arthur presented calculations on the prepayment option available for PERS contributions and potential savings to the City. A new agenda item for the May 22, 2013 meeting was created to explore the impact of PERS prepayment.
