**MINUTES** 

A motion was made by Mr. Sesler and seconded by Mr. Parkin to approve the minutes of June 5, 2013. Upon a voice vote, the motion carried 8-0.

**PUBLIC COMMENTS**

COMMITTEE
MEMBER COMMENT

Mr. Sesler brought an article to the attention to the committee that was recently published in the Orange County Register. The piece discussed the exponential growth of unfunded pension liabilities and the adverse impact on city budgets in the county as well as the state at

large.

## **OLD BUSINESS**

The committee began work on the second iteration of the expert question list. The list was consolidated and revised by Mr. Warren and put into excel format by Mr. Arthur. Public comment by Mr. Don Drozd of the OCEA suggested that the committee separate investment return and actuarial questions. Discussion between the committee and Mr. Drozd subsequently focused on the ongoing bankruptcy proceedings in San Bernardino and pension obligation status as a part of creditor claims. Mr. Sesler and Mr. Mora have been charged with further refining the question list. Mr. Mora has proposed categorizing the questions into the four following buckets: Actuary, Investments, Legal, and General Questions. Mr. Drozd informed the committee of a contribution proposal that the OCEA has submitted to the Treasury department and how the OCEA believes the city arrived at the unfunded status via poor market returns and enhanced compensation. Mr. Sesler and Mr. Mora will begin work on refining the list and bring their product for further review on 6/26/2013.

**NEW BUSINESS** 

There were no new items discussed at this meeting.

OPEN DISCUSSION & FUTURE AGENDA ITEMS The committee discussed the OC LAFCO Fiscal Trend Analysis recently disseminated by Mr. Young and posted on the POC website. Mr. Arthur charged the committee to begin consideration of possible solutions to the pension gap including tax options originally proposed by Joe Nation. Mr. Young informed the committee that the City Council will begin discussions on how to fill the vacant seat on the POC at the next Council meeting.
