SOBECA Art Walk - ARTery at the LAB

- ➤ Lisa and Frank met with Ayla to partner with the Committee overseeing the ARTery.
- ➤ To assist with the public awareness of the ARTery the Cultural Arts Committee proposes the following partnership with SOBECA:
 - Provide a resident artist to create live art in the ARTery four-five days a week from March –December 2014. The resident artist will open and close the ARTery during the days they are creating art.
 - Each month invite a guest artist to create art for three weeks in the ARTery and display their art during the Art Walk (in the ARTery). The fourth week the artist will take art down and clean the ARTery.
 - Invite other artists to paint live outside the ARTery during the summer Art Walks.
 - Promoting the ARTery by hosting two (2) (May & September) art receptions (on a Saturday) for the public to attend.
- ➤ The concept is for a resident artist (Al McCoy) to use the right small container of the ARTery as a live art studio and open the ARTery four-five days a week.
- ➤ Each month for three weeks a guest artist will create live art in the left small container and display their art during the Art Walk in the large gallery container. The fourth week the guest artist takes down art and cleans the ARTery for the next guest artist.
- ➤ During the Feb Art Walk (2/25 6-10pm) wooden panels will be displayed and Artist Al McCoy will paint live.
