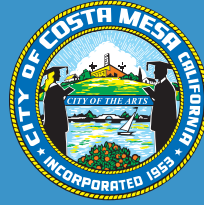


TITLE 20

Title 20 also prohibits the following activities:

- Using a garage for living space or a meeting room.
- Unfinished or abandoned construction.
- Accumulation and storage of rubbish, trash, debris in yards visible from a public right-of-way.
- Living in a stored vehicle or recreational vehicle.
- Abandonment or neglect of a swimming pool or spa.
- Housing Code violations (broken windows, peeling paint, torn window screens, dry rot).
- Dead or dying landscaping in the front yard and/or parkway.
- Litter, trash, and/or other debris visible from the street.
- Improper disposal of oil, grease, and other hazardous wastes.
- Operating a business without Planning approval and a business license.
- Installation of signs and banners without Planning approval and a permit.

As of January 7, 2011, storage of inoperable vehicles where they can be seen from the street, even if under a fitted car cover, will be prohibited. Consequently, all inoperable vehicles must be registered with the DMV or be stored in a garage or behind a six-foot high fence or they should be removed from the property.

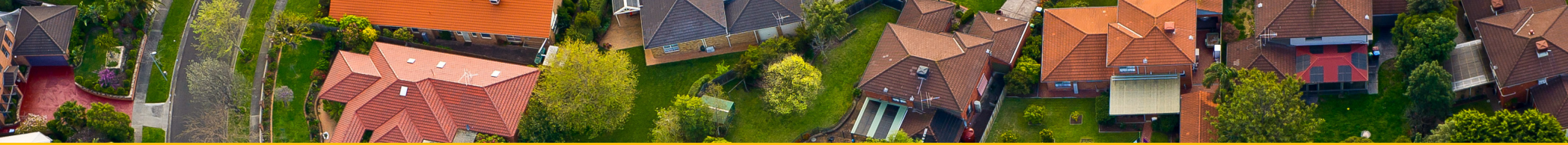

Private Property Maintenance Standards (Title 20)

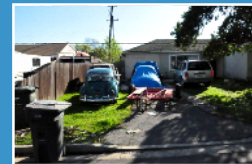
Poorly maintained homes and properties can lower your neighborhood property values; negatively affect community pride; and contribute towards crime as well as health and safety hazards. This brochure summarizes numerous property conditions prohibited by the City of Costa Mesa.

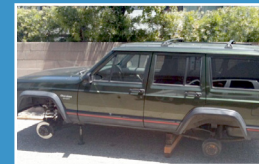
Costa Mesa City Hall is located at 77 Fair Drive, across from the Orange County Fairgrounds. The Code Enforcement office is located on the 2nd floor.

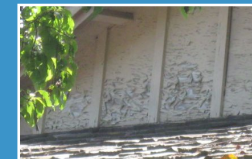
Examples of Violations:



Parking or storage of any operable vehicle in the front yard. Parking is only allowed in a garage or carport, or on a paved driveway.



Inoperative, wrecked, abandoned, or dismantled motor vehicles not stored in a garage or behind a six-foot high fence.



Peeling paint.



Weedy and/or overgrown vegetation.
