**AMENDMENT NUMBER ONE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH THE CITY OF MISSION VIEJO**

This Amendment is made and entered into this 6th day of August, 2014 (“Effective Date”) by and between the CITY OF COSTA MESA, a municipal corporation (“City”) and the CITY OF MISSION VIEJO, a California general law city and municipal corporation (“Consultant”).

WHEREAS, Consultant and City entered into an agreement on December 4, 2013, for Consultant to provide certain IT services which is more particularly described in Exhibit A of the same December 4, 2013 agreement (the “Agreement”); and

WHEREAS, Consultant and City desire to amend the hourly billing rate for Billing Title “Network Administrator or IT Specialist” as provided in Exhibit D of the Agreement; to increase the total compensation of the Agreement; and, at the end of the initial term period of the Agreement, to allow for a renewal the Agreement for up to two (2) term periods of six (6) months each.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Section 4.1 of the Agreement is hereby amended to state that, at the end of the initial term period of the Agreement, Consultant and City may mutually agree, in writing, to renew the Agreement for up to two (2) term periods of six (6) months each.
2. The compensation provided under Section 2.1 of the Agreement is hereby increased by Fifty Thousand Dollars (\$50,000).
3. Exhibit D of the Agreement is hereby amended to state that the hourly billing rate for the Billing Title “Network Administrator or IT Specialist” shall be \$65 an hour.
4. Except as set forth herein, the terms of the Agreement shall remain in full force and effect.
