Mr. Dunivent informed the committee that he would discuss POC's August 6, 2014 letter to City Council "Recommended Safety Employees Increase Pension Cost-Sharing to 14%" with Council in closed session on September 2, 2014. Mr. Dunivent also informed the committee the CalPERS valuations will not be released until late October. Mr. Hutchins informed the committee about a lot of negative reaction to the CalPERS approval of the 100 item special pay.
