Council Member Genis requested adding monitoring the planning of properties owned by other government agencies in the City of Costa Mesa; a goal be added to Public Services to coordinate all improvements with local residents and businesses in the early planning stages; that all the Capital Improvements include the estimated annual operating costs; a Traffic Study for SoBeca; and funding of the Police Station Emergency Generator.
