AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH FIRE INFORMATION SUPPORT SERVICES, INC.

THIS AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT ("Amendment"), is made and entered into July 1, 2015, ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation (the "City") and FIRE INFORMATION SUPPORT SERVICES, INC., a California corporation ("Consultant").

Recitals

WHEREAS, the City and Consultant entered into a Professional Services Agreement on July 1, 2013, (the "Agreement") to provide certain fire information support consultant services (the "Agreement"); and

WHEREAS, the original term of the Agreement was for one year, with an option to renew for up to three-one year terms; and

WHEREAS, City and Consultant exercised the option to renew the Agreement after the expiration of the original term and now desire to renew the Agreement for the 2015-2016 fiscal year; and

WHEREAS, City and Consultant also desire to increase the compensation total for 2015-2016 fiscal year.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged; the parties hereby amend the Agreement as follows:

- 1. The Agreement is renewed for the 2015-2016 fiscal year through June 30, 2016.
- 2. Compensation for services rendered from July 1, 2015 through June 30, 2016, shall be in accordance with the Statement of Work attached hereto as Exhibit "A" and incorporated herein by this reference.
- 3. Section 2.1 of the Agreement is hereby amended to reflect the compensation increase of Seventeen Thousand Three Hundred (\$17,300.00) as the new total not-to-exceed compensation limit for the 2015-2016 fiscal year.
- 4. All other terms and provisions of the Agreement shall remain in full force and effect.
