

AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT ("Amendment"), is made and entered into October 15, 2015 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation (the "City") and ALLIED NATIONWIDE SECURITY, INC., a California corporation ("Consultant").

Recitals

WHEREAS, the City and Consultant entered into a Professional Services Agreement on June 10, 2014 (the "Agreement") to provide one unarmed security officer at the Costa Mesa Senior Center, Monday through Friday, 7:30 a.m. to 4 p.m.; and

WHEREAS, the Parties desire to amend the Agreement to expand the scope of services and increase the compensation accordingly.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby amend the Agreement as follows:

1. The services set forth in Exhibit "A," attached hereto and incorporated herein by this reference, shall be added to the existing scope of services of the Agreement.
2. Section 2.1 of the Agreement is hereby amended to provide that Consultant shall be paid in accordance with the fee schedule set forth in Exhibit A to the Agreement and the fee schedule set forth in Exhibit A to this Amendment. Section 2.1 is further amended to provide that Consultant's total compensation shall not exceed Thirty Thousand Seven Hundred Fifty Dollars (\$30,750.00) annually.
3. All other terms and provisions of the Agreement shall remain in full force and effect.
