

**AMENDMENT NUMBER THREE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH MIG**

This Amendment is made and entered into this 30 of October, 2015, ("Effective Date") by and between the CITY OF COSTA MESA, municipal corporation ("City") and MOORE IACOFANO GOLTSMAN, INC. ("MIG"), a California Corporation ("Consultant").

**WHEREAS**, Consultant and City entered into an agreement on June 5, 2012, (the "Agreement") for Consultant to provide services more fully described in Consultant's Scope of Work; and

**WHEREAS**, Consultant and City desire to amend the Agreement to adjust the amount of compensation from the existing compensation limit of Eight Hundred Thirty Eight Thousand Four Hundred and Fifty Dollars (\$838,450.00), to a not-to-exceed amount of Eight Hundred Eighty Eight Thousand Nine Hundred and Five Dollars (\$888,905.00); and

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Section 2.1, Compensation, shall be amended to read, "As compensation for the provision of services outlined in Exhibit "A" and in accordance with this agreement, Consultant shall be paid in accordance with the fee schedule set forth in Exhibit "B," attached hereto and incorporated by reference. Consultant's total compensation shall not exceed Eight Hundred Eighty Eight Thousand Nine Hundred and Five Dollars (\$888,905.00).
2. All terms not herein defined shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the successor Agreements not in conflict with this Amendment, shall remain in full force and effect.


