NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a Public Hearing will be held by the Costa Mesa City Council at the regular meeting on Tuesday, **December 1, 2015**, at 7:00 p.m. or as soon as possible thereafter, in the Council Chambers of City Hall, 77 Fair Drive, Costa Mesa, California, for the purpose of considering the Mandatory Commercial Waste and Organics Recycling Ordinance that would amend Article 1 (Solid Waste Collection) of Chapter IV (Garbage, Rubbish and Weeds) of Title 8 of the Costa Mesa Municipal Code Sections 8-76 (Definitions), 8-77 (Permit) and 8-83 (Regulations).

The Council will also receive for first reading, Ordinance No. 15-16: **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, TO AMEND TITLE 8 OF THE COSTA MESA MUNICIPAL CODE BY AMENDING SECTION 8-76 (DEFINITIONS), 8-77 (PERMIT) AND 8-83 (REGULATIONS) OF ARTICLE I (SOLID WASTE COLLECTION) OF CHAPTER IV (GARBAGE, RUBBISH AND WEEDS)**

At said Public Hearing, all persons either favoring or opposing the proposed Ordinance will be heard.

Public Comments: Public comments in either oral or written form may be presented during the public hearing. Any written communications, photos, or other material for copying and distribution to the City Council that is 10 pages or less, must be submitted to the City Clerk NO LATER THAN 3:00 P.M. on the day of the hearing, **December 1, 2015** and can also be emailed to cityclerk@costamesaca.gov. If the public wishes to submit written communication, photos, or other material for distribution to the City Council at the meeting AFTER 3:00 p.m., 10 copies will need to be provided for distribution. Please note that NO copies of written communication will be made AFTER 3:00 p.m. Any materials to be displayed on the overhead projector at the Council Meeting must be submitted to the City Clerk NO LATER THAN 15 MINUTES PRIOR TO THE START OF THE MEETING. IF THE AFOREMENTIONED ACTION IS CHALLENGED IN COURT, the challenge may be limited to only those issues raised at the public hearing described in the notice, or in written correspondence delivered to the City Council at, or prior to, the public hearing.
