**NOTICE IS HEREBY GIVEN** that a Public Hearing will be held by the Costa Mesa City Council at the regular meeting on Tuesday, **January 5, 2016**, at 7:00 p.m. or as soon as possible thereafter, in the Council Chambers of City Hall, 77 Fair Drive, Costa Mesa, California, for the purpose of considering for first reading proposed Ordinance No. 16-02 entitled: **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, ADOPTING CODE AMENDMENT CO-15-07, AMENDING TITLE 10, CHAPTER XI (STOPPING, STANDING OR PARKING RESTRICTED OR PROHIBITED ON CERTAIN STREETS), ARTICLE 3 (PARKING BY PERMIT ONLY) RELATED TO RESIDENTIAL PARKING RESTRICTIONS**

Regular business hours will resume on Monday, January 4, 2016.**

At said Public Hearing, all persons either favoring or opposing the proposed ordinances will be heard.

**Public Comments:** Public comments in either oral or written form may be presented during the public hearing. Any written communications, photos, or other material for copying and distribution to the City Council that is 10 pages or less, must be submitted to the City Clerk NO LATER THAN 3:00 P.M. on the day of the hearing, **January 5, 2016** and can also be emailed to [cityclerk@costamesaca.gov](mailto:cityclerk@costamesaca.gov) If the public wishes to submit written communication, photos, or other material for distribution to the City Council at the meeting AFTER 3:00 p.m., 10 copies will need to be provided for distribution. Please note that NO copies of written communication will be made AFTER 3:00 p.m. Any materials to be displayed on the overhead projector at the Council Meeting must be submitted to the City Clerk NO LATER THAN 15 MINUTES PRIOR TO THE START OF THE MEETING. IF THE AFOREMENTIONED ACTION IS CHALLENGED IN COURT, the challenge may be limited to only those issues raised at the public hearing described in the notice, or in written correspondence delivered to the City Council at, or prior to, the public hearing.
