AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA TO AMEND TITLE 13, CHAPTER VIII, SIGNS, OF THE COSTA MESA MUNICIPAL CODE RELATED TO TEMPORARY PORTABLE SIGNS.

**NOTICE IS HEREBY GIVEN** that a public hearing will be held by the Costa Mesa City Council at the regular meeting on **Tuesday**, **July 5**, **2016 at 7:00 P.M.**, or soon thereafter as the matter shall be heard, in the City Hall Council Chambers, 77 Fair Dr., to consider Code Amendment CO-16-01 to amend Title 13 (Zoning Code), Chapter VIII, Signs, of the Costa Mesa Municipal Code. The Code amendment involves amending regulations applicable to temporary portable signs which are not permanently affixed to the ground or a structure(s). The scope of the proposed changes is limited to the physical regulation of temporary portable signs. Environmental Determination: Exempt.
