SUMMARY OF PROPOSED ORDINANCE  
ORDINANCE NO. 16-04**

**NOTICE IS HEREBY GIVEN** that on Tuesday, July 5, 2016, the City Council introduced proposed Ordinance No. 16-04:

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA TO AMEND TITLE 13, CHAPTER VIII, SIGNS, OF THE COSTA MESA MUNICIPAL CODE RELATED TO TEMPORARY PORTABLE SIGNS.**

Ordinance No. 16-04 introduces an Ordinance that would consider adoption of Code Amendment CO-16-01 to amend Title 13 (Zoning Code), Chapter VIII, Signs, of the Costa Mesa Municipal Code. The Code amendment involves amending regulations applicable to temporary portable signs which are not permanently affixed to the ground or a structure(s). The scope of the proposed changes is limited to the physical regulation of temporary portable signs. Environmental Determination: Exempt.

A certified copy of the full text of Ordinance No. 16-04 is posted and may be read in the City Clerk's Office, 77 Fair Drive, Costa Mesa. The City Council will consider adoption of the proposed ordinance at the regular meeting on **August 2, 2016 at 5:45 p.m.**

**Public Comments:** Public comments in either oral or written form may be presented during the public hearing. Any written communications, photos, or other material for copying and distribution to the City Council that is 10 pages or less, must be submitted to the City Clerk **NO LATER THAN 3:00 P.M.** on the day of the hearing, **August 2, 2016** and can also be emailed to [cityclerk@costamesaca.gov](mailto:cityclerk@costamesaca.gov). Please note that records submitted by the public will not be redacted in any way and will be posted online as submitted, including any personal contact information. If the public wishes to submit written communication, photos, or other material for distribution to the City Council at the meeting **AFTER 3:00 p.m.**, 10 copies will need to be provided for distribution. Please note that **NO** copies of written communication will be made **AFTER 3:00 p.m.** Any materials to be displayed on the overhead projector at the Council Meeting must be submitted to the City Clerk **NO LATER THAN 15 MINUTES PRIOR TO THE START OF THE MEETING.** If you should need further assistance, please contact the City Clerk's Office at (714) 754-5225. The City Council agenda and related documents may also be viewed on the City's website at <http://costamesaca.gov>, 72 hours prior to the public hearing date.

**IF THE AFOREMENTIONED ACTION IS CHALLENGED IN COURT**, the challenge may be limited to only those issues raised at the public hearing described in the notice, or in written correspondence delivered to the City Council at, or prior to, the public hearing.
