OLD BUSINESS

Subcommittee Reports

- 1. Identify Costa Mesa Notable Residents
 - Karen, Dave Gardner, and Gary discussed the proposed notable residents (Edrick Miller, Hank Panian, Walter Ozment, and Herb Jenks) with the Committee. It was decided that the committee members would review Mr. Panian, Mr. Ozment, and Mr. Jenks's biographies and discuss for approval at next meeting.

2. Then & Now Historical Buildings

 Dave Goodman requested copies of the "Old Town Costa Mesa Historical Marker" pamphlet. He requested that the committee discuss potential fundraising opportunities to cover the cost of future markers and their installation. This discussion will be added to the next agenda.

3. Mills Act

 Mary Ellen reported that she looked up homes on the list at the Costa Mesa Historical Society and had some difficulty finding additional information on the history of the homes. She said the Historical Registry lists addresses, but that the street names and numbering systems are often different now than they were then. • Staff will work with the City's Department of Development Services to gather information on the Mills Act and provide findings to the committee.

4. Costa Mesa Artifact Research

- Staff informed the committee that research is ongoing and that the archeologist requested information on how the committee is planning to showcase artifacts if granted the permission.
- The committee suggested various locations such as the Costa Mesa Historical Society or other local places depending on the value, size, and other factors of the item to be displayed.
