## AMENDMENT FOUR TO PROFESSIONAL SERVICES AGREEMENT

THIS AMENDMENT FOUR TO PROFESSIONAL SERVICES AGREEMENT ("Amendment Four"), is made and entered into January 26, 2017 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and CALIFORNIA FORENSIC PHLEBOTOMY, a California corporation ("Consultant"). City and Consultant shall hereinafter collectively be referred to as "Parties".

## RECITALS

**WHEREAS**, the City and Consultant entered into a Professional Services Agreement on January 27, 2012 ("Agreement") to perform blood sample collections;

**WHEREAS**, the Parties entered into the Agreement for three (3) years with options to renew up to four (4) one (1) year terms;

**WHEREAS**, the Parties extended the term of the Agreement utilizing the first option to renew for one (1) year, which extended the term through January 25, 2016;

**WHEREAS**, the Parties extended the term of the Agreement utilizing the second option to renew for one (1) year, which extended the term through January 25, 2017;

**WHEREAS**, now the Parties desire to extend the term of the Agreement, by and through this Amendment Four, utilizing the third option to renew for one (1) year, which extends the term through January 25, 2018;

WHEREAS, pursuant to authority granted to the Chief Executive Officer, on March 25, 2015, the Parties enter into this Amendment Four to the Professional Services Agreement extending the term of the original Agreement; and

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged; the Parties hereby amend the Agreement as follows:

- 1. Section 4.1 of the Agreement is hereby amended to change the date of termination to January 25, 2018.
  - 2. Compensation to Consultant shall remain the same.
- 3. All other terms and provisions of the Agreement and all amendments, shall remain in full force and effect.
