AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH COMPLETE LANDSCAPE CARE, INC.

This Amendment Number Two ("Amendment") is made and entered into this 9th day of January, 2017 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and COMPLETE LANDSCAPE CARE, INC., a California corporation ("Contractor").

WHEREAS, City and Contractor entered into an agreement on March 1, 2015 for Contractor to provide landscape maintenance services ("Agreement"); and

WHEREAS, City and Contractor previously amended the Agreement to increase Contractor's compensation and to allow additional increases in Contractor's compensation based on the Consumer Price Index (CPI); and

WHEREAS, City and Contractor now desire to amend the Scope of Services to include the additional services set forth in Exhibit "A," attached hereto and incorporated herein by this reference; and

WHEREAS, City desires to increase Contractor's maximum annual compensation accordingly to Seven Hundred Thirty-Six Thousand Five Hundred Forty-Two Dollars and Thirty-Eight Cents (\$736,542.38).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
- 2. Section 2.1 of the Agreement shall be amended to reflect that Contractor's total annual compensation shall not exceed Seven Hundred Thirty-Six Thousand Five Hundred Forty-Two Dollars and Thirty-Eight Cents (\$736,542.38). Contractor shall be paid according to the fee schedule set forth in the Agreement and Exhibit A of this Amendment.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
