Chair Ashendorf: Advised has been a 15-year resident of Costa Mesa, was an original member of the Costa Mesa Board of Directors, active volunteer at the [Senior] Center, also serves on the Cultural Arts Committee, and on foundation for the Friends of the Library, advised really excited to be a representative for the Seniors.
