

**AMENDMENT NUMBER THREE
TO PROFESSIONAL SERVICES AGREEMENT
WITH MIKE LINARES, INC.**

This Amendment is made and entered into this 1st day of July, 2017, ("Effective Date") by and between the CITY OF COSTA MESA, municipal corporation ("City") and MIKE LINARES, INC., a California Corporation ("Consultant").

WHEREAS, Consultant and City entered into an agreement on September 2nd, 2014, (the "Agreement") for Consultant to provide CDBG/HOME Coordinator services ("Services"); and

WHEREAS, the original Agreement contained a provision for an initial term of twelve (12) months with the option to extend the Agreement for up to four (4) term periods of one (1) year each; and

WHEREAS, Consultant and City exercised the first two extensions; and


WHEREAS, Consultant and City wish to amend the Agreement to exercise the third extension; and

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. The Agreement is renewed until June 30, 2018.
2. Consultant will be paid in accordance with the revised fee schedule set forth in Exhibit "B," attached hereto and incorporated by reference. The not to exceed amount referenced in Section 2.1 will remain as Eighty Seven Thousand Five Hundred Dollars and Zero Cents (\$87,500.00).
3. All terms not herein defined shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the successor Agreements not in conflict with this Amendment, shall remain in full force and effect.
