## AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT WITH G & W TOWING, INC.

This Amendment Number One ("Amendment") is made and entered into this 5th day of July, 2017 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and G & W TOWING, INC., a California corporation and licensed automobile towing service ("Contractor").

WHEREAS, City and Contractor entered into an agreement on July 1, 2017 for Contractor to perform towing services (the "Agreement"); and

WHEREAS, City and Contractor desire to amend the Scope of Services to include towing services for medium duty and heavy duty City vehicles and equipment, and to set forth Contractor's maximum annual compensation for such services accordingly.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- The Scope of Services shall be amended to include towing services for medium duty and heavy duty City vehicles and equipment.
- 2. Contractor's annual compensation shall not exceed Five Thousand Dollars (\$5,000.00) for the medium duty and heavy duty towing services. City shall pay Contractor according to the fee schedule attached hereto as Exhibit "A" and incorporated herein by this reference.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
