### 4. OLD BUSINESS

- A. Youth Art Gallery (YAG)
  - 1. Charlene recognized the City of Costa Mesa's R.O.C.K.S Program for their participation in February.
- B. The Exhibit at the Senior Center
  - 1. Charlene spoke on the Exhibit's sale procedures and noted that for all sales that take place, the Committee receives 10% commission. She then explained that Memories in the Making Program from the Alzheimer's Association has requested to receive full commission of their sales. After a brief discussion the group unanimously denied their request.
- C. Directory of the Arts
  - Staff explained that the web designer has all the information necessary to update the directory and it should be completed within the next two (2) weeks.
- D. Art in Public Places Utility Box Art
  - Frank informed the members that the Papa Murphy's design has been installed (off of Harbor Blvd & Wilson St.) and he has been receiving positive reviews.

- 2. Kathleen presented the proposed artwork from a group of Senior Center artist. After a brief discussion, Kathleen made the motion to accept the proposed artwork for the 19<sup>th</sup> Street and Pomona Street utility box and Lisa 2<sup>nd</sup> the motion. The motion was approved unanimously.
- 3. Staff recommended to increase the approved funds for the program to account for the sponsored boxes. Chrystal made the motion to mend the current Purchase Order by \$6,000. The motion passed unanimously.
- 4. Frank presented graphics from artist Paul Ortega and explain that the sub-committee denied his artwork because they didn't feel is was suitable for the project. The Committee agreed, but did admire the Kobe Bryant art piece. Members requested for staff to seek legal advice to see if using a celebrity's, like Kobe Bryant's, face or image on public art is legal.
