- Call to Order: The Parks and Recreation Commission meeting was called to order by Chair Pederson at 6:00 p.m. on August 24, 2017 at City Hall, 77 Fair Drive, Costa Mesa, California.

4. Approval of the Minutes of the July 27, 2017 Meeting of the PRC

5. Public Comments

- 1. Tom Hatch, City Manager, spoke about re-closing the restrooms at Lions Park, posting a police officer during park hours and moving the construction fence.
- 2. Jay Humphrey, Costa Mesa, spoke about his ongoing concerns regarding the lack of prosecution against the individual who vandalized a vernal pool at Fairview Park in March 2017, discrepancy regarding fairy shrimp in the report documenting the damage, Measure AA not being written into City ordinances and Municipal Code, and waiting for the Fairview Park Steering Committee to take action.
- 3. Bill McCarty, Costa Mesa, represented Orange County Earth Stewards, invited the commissioners and public to assist the Army Corps of Engineers to clean up the Santa Ana River Marshes on September 16, 2017, asked the commission to help arrange a shuttle to the clean-up location, and expressed concern about Facebook attacks from Costa Mesa Public Square.

- 4. Flo Martin, Costa Mesa, spoke about Wilson Park needing picnic tables.
- 5. Rocky Evans, Costa Mesa, spoke about wanting to extend the hours at the Costa Mesa Skate Park.
- 6. Kim Hendricks, Costa Mesa, thanked Commissioner Ersoylu for responding to pictures showing left-over debris in Fairview Park from the February restoration, requested a meeting with the Commission to discuss discrepancies within the reports on Fairview Park damage, spoke about the relationship between US Fish and Wildlife and the City, and voiced concern about trash at vernal pools 5, 6 & 7.
- 7. Speaker, spoke about a non-ADA compliant sidewalk, a potential safety risk regarding a long drop on the same sidewalk, a tree blocking a stop sign on 19th Street and a small lot ordinances petition.

6. Commissioner Comments

Commissioner Ersoylu – Spoke about the recent events in Charlottesville beginning in a park, asked the public to condemn hate and use public spaces as places for communities and families to congregate and recreate positively.

Commissioner Bogner – Apologized for recent absences and presented a report on her appointed parks. Brentwood Park: the slide is in the process of being repaired, shared contact information for the "Friends of Brentwood Park" wall, thanked staff for providing waste bag receptacles in all assigned parks. Harper Park: the water fountain will be cleaned by staff. Heller Park: dirty restroom and transient population using them, playground is in good condition. Jordan Park: playground is in good condition. Lindbergh Park: equipment is in good condition, standing water has been reported. Pinkley Park: graffiti has been reported. All parks had dogs off leash. She encouraged the community to use Costa Mesa Connect, spoke about the increase in the transient population in and around Wilson Park, spoke about attending the Hi-Time Chili Cookoff and the Palm Harvest/Estancia High School Football Spaghetti Dinner.

Chair Pederson – Thanked City Manager, Tom Hatch, for his work and support, empathized with Commissioner Ersoylu regarding recent personal attacks, applauded his fellow Commissioners for a job well-done, encouraged the community to use Costa Mesa Connect and thanked staff for quick response time.

Chair Pederson shared an email statement written and submitted by Commissioner Reynolds apologizing for her absence. She was traveling to Wyoming, to view the total eclipse and four national parks. She would like to remind the community of upcoming clean up events.
