1. CALL TO ORDER

The Summer Art Show would showcase artists painting as well as skateboarders skating. The event would be held on Saturday, August 7. Art sold at the event would benefit the OC Skateboarding League. A discussion on how the art would be sold was brought up. Lisa and Katrina will do some research on the subject.

Barbara made a motion for the Committee to promote the event at the "Art in the Park" event(s), email blast the Artist Directory with information for interested artists to contact an OC Skateboarding League member and for the subcommittee members to be involved the day of; seconded by Irene; passed unanimously.

Barbara will take the lead and a subcommittee will be formed at the May meeting.

5. OLD BUSINESS

Subcommittee Reports

1. Artist Showcase March 13 @ Whittier Law School (recap)

- About 500 people attended the event and a majority commented on how wonderful the venue setup was as well as how the art displayed was very professional.
- o Overall cost was \$1398.
- o Irene mentioned that changing the showcase hours from 6-10pm to 6-9pm would have worked better for the Whittier Law School venue, the Committee decided that showcase hours would be determined based on the venue.
- o \$1,901.56 remains in the 2009-10 budget.

2. Art at the Park (Summer Concerts Series) (Subcommittee's report)

- Irene made a motion for the Committee to purchase face paint supplies, craft supplies (have CMHS cheerleaders design the crafts) and email blast the Artist Directory for "Live Art" (participating artists will paint during concert);seconded by Barbara; passed unanimously.
- Monet suggested that eVocal get involved in perhaps two of these events by setting up the handscreen printing machine and printing T-shirts, caps and/or totes. It was suggested that Brett put together a proposal.

3. Sponsorship (Subcommittee report)

- Lisa informed the Committee about the Community Foundation Board guidelines for approving funding. A budget of upcoming events needs to be presented to the Community Foundation Board each year. Items approved by the CFB will be purchased on the City's Procurement card, a Check Request form will be submitted to the CFB, once approved the CFB will reimburse the City.
- The City Council was informed of the Sponsorship program at the April 6
 meeting. Once the account has been official set up, pamphlets will be
 available at Community Centers, City Hall, City Libraries, City's
 Website and other local businesses. Committee members will begin to
 obtain donations. Lisa will post the pamphlet on the City's website and
 on Facebook.
- Barbara requested to be taken off the subcommittee and Ryan accepted the lead.
- Katrina mentioned that she would like to get involved.
- It was suggested that the brochure be handed out at Art in the Park as well as the Artist Showcases.

4. Mural Art Project (Subcommittee report)

- The subcommittee is gathering more information for staff to present the project idea to the City Council.

- 6. Auctions/Selling Art Images
