# 9a. Weekend Park Tours

Chairman Mike Brumbaugh made a brief presentation.

Ms. Jana M. Ransom provided members of the Commission with information from previous park tours held by the Commission in 2008.

Commissioner Kim Pederson stated that the park tours will give the Commissioners the opportunity to get out into the community, see the parks, walk around, and to receive public input.

Commissioner Kim Pederson mentioned that he will volunteer for the first park tour.

#### Public Comments:

#### 1. Mr. Roger Bushon

Mr. Bushon voiced his concern to the Commission on noticing the public for the park tours. He suggested that signage be placed in the parks that are scheduled for the tour in order to receive community input.

#### 2. Ms. Beth

Ms. Beth addressed the Commission on past park tours. She believes that the park tour is a great idea and that neighborhood residents will be able to provide input.

Chairman Mike Brumbaugh said that noticing the public, by posting a schedule on the City's website, about the park tour is one of the goals for the Commission.

Commissioner Kim Pederson mentioned that he would like to volunteer for the first park tour. He said that he is available on Saturdays and suggested the tour be held on the third Saturday. Commissioner Kim Pederson also recommended that signage be placed a week in advanced at each park that will be toured. He went on to suggest that the schedule be done in three separate tours.

Chairman Mike Brumbaugh asked the members of the Commission for a second volunteer for the first park tour.

Vice Chairman Terry Shaw said that he wholeheartedly supports this concept and that he is not available in the month of June. Vice Chairman Terry Shaw volunteered for the second set of tours.

Commissioner Jeff R. Mathews volunteered for the second and/or third park tours. He recommended that the Commission follow the same or similar set of schedules to tour the parks as noted in the 2008 schedules, pending an actual date, and to also set a tour in June, another in July, and a third in August.

Chairman Mike Brumbaugh mentioned that he would volunteer for the first tour, unless Commissioner Kurt M. Galitski decides to volunteer for the tour. Chairman Mike Brumbaugh said that he is available on any other Saturday in June, except for June 12 and 19.

Mr. Peter Naghavi provided the Commission with a brief history on the past park tours held in 2008.

# 10b. <u>Tree Removal Request - 3031 Capri Lane</u>

Mr. Bruce A. Hartley made a power point presentation.

Discussion between Commissioner Jeff R. Mathews and Mr. Hartley ensued on the tree growth.

Ms. Fielder voiced her concerns to the Commission on her tree removal request.

Discussion between Chairman Mike Brumbaugh and Ms. Fielder took place on the tree removal and replacement costs.

Discussion between Chairman Mike Brumbaugh and Mr. Hartley occurred on root pruning, root barriers, and on the sidewalk damage.

Motion made by Commissioner Jeff R. Mathews, seconded by Vice Chairman Terry Shaw and carried three to one, with Commissioner Kim Pederson voting "No" and Commissioner Kurt M. Galitski being absent, to authorize the removal and replacement of the trees at 3031 Capri Lane, per the Streetscape and Median Development Standards, Section 4.0.3 – Dis125

cretionary Removals, which would require replacement of the trees with one (1) twenty-four inch box-size tree and two (2) fifteen gallon-size trees to be planted elsewhere on City property, for each tree removed. The applicant would pay all removal and replacement costs.

The trees must be removed and mitigation trees provided to the City within one year from the date of final approval, after which the approval expires.

# 10c. <u>Afterschool Program</u>

Chairman Mike Brumbaugh briefly stated that he requested for this item to be agendize so that staff may provide the Commission with background history of the Afterschool Program and on possible remedies to keep the program in place.

Discussion between Chairman Mike Brumbaugh and Mr. Naghavi occurred on the funds and history of the Priority Sidewalk Repair Program.

Motion made by Vice Chairman Terry Shaw, seconded by Commissioner Kim Pederson and carried four to zero, with Commissioner Kurt M. Galitski being absent, to approve the following:

- 1. The proposed Fiscal Year 2010-2011 Capital Improvement Program (CIP) as it relates to Parkways, Park Maintenance, and Park Improvements; and,
- 2. The proposed 7-Year Capital Improvement Program (CIP) as it pertains to the categories of Curbs and Sidewalks, Community Health and Environment, and Leisure and Community Services.

Chairman Mike Brumbaugh recognized Park Ranger Matt Pallo and all the Park Ranger's for their hard work.

Discussion between Vice Chairman Terry Shaw and Ms. Ransom ensued on the impacts to programs held at the Balearic Community Center facility in light of the proposed City budget cuts.

Commissioner Kim Pederson thanked the School District for working closely with the City.

# 12. <u>Commissioner's Comments</u>

Commissioner Kim Pederson congratulated Mr. Dave Gardener for his efforts in contributing so much to the City and the community.

Commissioner Jeff R. Mathews stated that tree removal requests brought forth to the Commission are typically at the owner's expense and not the City's, and that for every tree removed the City requires a 3:1 tree replacement ratio.

Commissioner Jeff R. Mathews suggested that the Commission consider neighborhood plantings for stretches of land or streets where there is a dearth of trees, and to notice residents of their option to opt-out of planting.

Commissioner Jeff R. Mathews stated that he mimics Chairman Mike Brumbaugh's comments about the Park Rangers. He thanked the Park Rangers for their excellent service.

Commissioner Jeff R. Mathews commended Mayor Allan R. Mansoor and the City Council for the recent adoption of the Rule of Law Designation for the City of Costa Mesa.

Commissioner Jeff R. Mathews reminded voters about the June 8 Primary Election, and he encouraged voters to educate themselves on the candidates and on the initiatives in order to make an informed choice.
