#### 8. Presentation

## a) Friends of the Costa Mesa Libraries

Ms. Donna Stapleton presents on musical instruments she would like to see installed at the Mesa Verde Library.

Commissioner Erickson thanked Ms. Stapleton and spoke about how worthy the cause is.

Commissioner Bogner spoke about the beautiful aesthetic.

Vice Chair Reynolds asked if there were any other parks in Orange County that have the instruments installed, and spoke about her experience with similar instruments in other locations.

Chair McNabb suggested Ms. Stapleton look into donations from local arts organizations.

## a) Skate Park Extended Pilot Program Update

#### **Public Comment:**

Chair McNabb closed public comments.

Commissioner Erickson spoke about the park being well utilized, but has concerns about the concrete being wet in the morning hours during the winter and asked if there is an ability to change the hours if issues arise.

Commissioner Bogner spoke about the possible, adverse effects of reducing the hours and the importance of giving administrative staff the authority to change the hours on an asneeded basis.

Vice Chair Reynolds agreed with the previous commissioner statements and reviewed the provided statistics in attachment 1 of the staff report.

Chair McNabb spoke in favor of keeping the extended hours, revisiting the item in 6 months, and her concern that 7:30am may be too early for staff to complete their work and have the gates opened.

**MOTION/SECOND:** Commissioner Bogner moves to end the pilot program and maintain the park hours, as set forth in the pilot program, with the caveat that administrative staff has the right to close the park as needed; and to provide an update in six months/Seconded by Vice Chair Reynolds.
