NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Costa Mesa City Council at its regular meeting on **Tuesday, March 19, 2019**, at 7:00 p.m. or soon thereafter as the matter shall be heard, at the Costa Mesa Senior Center, Grand Hall 1, 695 W. 19th Street, Costa Mesa, California, to introduce Ordinance No. 19-xx, which will consider Code Amendment CO-18-05 to amend Title 13 (Zoning Code), Chapter VIII, Signs, of the Costa Mesa Municipal Code. The Code amendment involves amending regulations to remove time periods for installation of non-commercial portable signs on private, residentially-zoned properties. The scope of the proposed changes is limited to the physical regulation of temporary portable signs.

Kindly submit to the City Clerk **AS EARLY AS POSSIBLE, BUT NO LATER THAN 30 MINUTES PRIOR TO THE START OF THE MEETING.
