## **PRESENTATIONS**

The Mayor presented the Mayor's Award to Estancia High School football coach Mike Bargas in recognition of his recent accomplishments and continued

involvement with the Estancia High School football team.

Christine Anderson, Sonora Elementary School Principal, and Talena Mara, Vice-President of Education at the Segerstrom Center of the Arts, provided an overview of the Sonora Elementary School and Segerstrom Center of the Arts partnership program, and the students presented their projects to members of staff and the Council.

The City CEO announced the upcoming Special Study Session and budget briefing, spoke about the 4th quarter sales tax report, provided details of the draft budget calendar, advised that additional special meetings would be held in May and in June relative to budget and it's processes, and stated that the Police Chief recruitment was to close at the end of the week.

## **PUBLIC COMMENTS**

Colin McCarthy, Costa Mesa, presented results of the Costa Mesa Taxpayers Association telephone poll results regarding the City's budget.

Marshall Krupp, Costa Mesa, President and CEO of World Solar Tech, offered his company's free consulting services to the City for a solar program.

Jay Photoglou spoke about his experience with the Police Department regarding his claim and public records requests.

Colin Laus, Costa Mesa, spoke about outsourcing and transparency and requested that Council rescind the notices.

Jay Humphrey, Costa Mesa, questioned a prior action of the City Council in declining the transfer of Redevelopment Agency (RDA) funds and spoke in support of city employees.

Perry Valantine, Costa Mesa, commented on the Feet to the Fire forum, staff reductions and overtime, and the EMS paramedic request.

Greg Thunell, Costa Mesa, expressed opposition in the outsourcing of employees.

James Proctor, Costa Mesa, suggested ideas for generating revenue such as parades, donation cans, and benefit concerts.

Mike Brumbaugh, Costa Mesa, announced an upcoming picnic and open house sponsored by the Halecrest Swimming and Tennis Club.

Diane Russell, Costa Mesa, spoke in opposition of outsourcing, questioned the facts relative to the financial situation of the city and asked Council to rescind the notices.

Sandra Genis, Costa Mesa, spoke about government transparency and

recommended that the Council working groups be opened to the public.

Karl Ahlf, Costa Mesa, expressed opposition in the outsourcing of police officers.

Paula Restis, Costa Mesa, spoke in opposition of outsourcing.

Martie O'Meara, Costa Mesa, commented on the apparent negative media by the labor unions and expressed support of the efforts of the City Council.

Karin W. Ahlf, Costa Mesa, spoke about the Costa Mesa Taxpayers' Association poll and expressed concern regarding the outsourcing of employees.

Eleanor Egan, Costa Mesa, shared a story of a business owner whose business failed due to his focus only on cuts and not on revenue generating ideas.

Reggie Mendekis, Costa Mesa, expressed concern regarding the surge in consultants and the "climate of fear" that was being created.

Helen Nenadal, President of the Costa Mesa Employees' Association, spoke about the morale of the employees.
