OPENING REMARKS:

Mike Linares informed the Committee their funding recommendations should be based on the assumption that \$162,000 will be available to fund grants. Of the \$162,000 available, \$19,000 has been allocated for Fair Housing, a HUD required service. The Committee's recommendation should include a Fair Housing grant.

In addition, Mike Linares explained to the Committee that a pre-setup rating sheet (pink in color) was generated for them. The rating criteria that the committee recommended five years ago was approved by the City Council. Mike went on to say that he pre-populated scores into the rating sheet based on the objective criteria. Mike also informed the committee that maximum scores are listed on the forms.

OLD BUSINESS:

NEW BUSINESS:

Muriel Ullman was invited to address the committee regarding the homeless outreach efforts in the City undertaken by the Network for Homeless Solutions (NHS). The NHS is a collaborative effort among city staff, volunteers, community, churches, nonprofit and private organizations to address homelessness in Costa Mesa. Through the efforts of the network, homeless individuals are identified and directed to resources that will best assist them in the interest of removing individuals from the city's streets, parks, private properties, and other areas of transient activity. Ms. Ullman also discussed how the public service grant applicants play a role in the City's larger homeless strategy and why funding for these applicants is important.

The Committee proceeded to interview applicants for FY 2019-2020 CDBG public service grants, and based on further discussions, developed a slate of funding recommendations for the City Council's consideration.
