3. SELECTION OF NEW CHAIR AND VICE-CHAIR

Member Ralph Taboada nominated Member Cynthia McDonald as Chair of Bikeway and Walkability Committee. Member Flo Martin seconded the motion. Motion passed unanimously.

Member Richard Huffman II nominated Member Ralph Taboada as Vice-Chair of Bikeway and Walkability Committee. Member Flo Martin seconded the motion. Motion passed unanimously.

4. PUBLIC COMMENTS

1. John C. Merrill, resident, introduced himself as a former committee member. He welcomed and shared ideas with new committee members.

5. APPROVAL OF MINUTES

Member Brent Stoll moved to approve the March 6, 2019 regular meeting minutes. Vice-Chair Ralph Taboada seconded the motion. The motion passed unanimously.

6. OLD BUSINESS

a. Committee Mission Statement/Introductions

Chair Cynthia McDonald opened the floor for committee member introductions. New committee members were introduced to the committee's mission statement and current work plan.

b. Pedestrian Focus/Walk Audits

Chair Cynthia McDonald shared notes and ideas with the committee. Mayor Katrina Foley suggested developing or finding an existing tool to assist with walk audit data collection. Council member Arlis Reynolds suggested creating a subcommittee to focus on developing walk audits. The Walk Audit Subcommittee was formed and members of the subcommittee follow: Michelle Fay, Chair, Council Member Arlis Reynolds, Fiorella Gardella, Bridget Gleason, Flo Martin, Cynthia McDonald, Kyle Ramer, and Ralph Taboada.

Raja Sethuraman, Public Services Director, reminded committee members that maintenance type issues should be reported to the City via the CM App. The walk audit tool should focus on long term improvement items especially if they require funding.

c. Mobility Share

Raja Sethuraman, Public Services Director, discussed a recent meeting with the Police Department, Fire Department, City Attorney's Office, and the Chief of Staff. He shared that the highest concern for both Police and Fire Departments is public safety. Both Departments would like to know what other nearby cities are doing to address and reduce safety concerns. The Chief of Staff will work with the Mobility Share Subcommittee to determine size of proposed program, staffing needs, and research items to address the concerns of the pilot program.

a. Bike to School Month - May

Jennifer Rosales, Transportation Services Manager, discussed the City's efforts to promote Bike Safety in the month of May. Staff will confirm if the Costa Mesa Police Department will be able to participate in Bike to School Day on May 8, 2019 at Victoria Elementary School. A bike rodeo is planned at Kaiser Elementary School on May 8, 2019. Council Member Arlis Reynolds suggested having CMTV present at the events to document the

activities.

b. OCC Green Coast Day

Member Kari Nieblas Vozenilek confirmed the committee was able to secure a booth at the event that will take place on April 17, 2019 at Orange Coast College.

c. Annual Bike/Walk Events

Chair Cynthia McDonald opened the item for discussion. Committee members identified the following events as potential Annual Bike and Walk Events: Walk to School in October, Bike to School in May, Cyclovia in the future, Scarecrow ride in October, Holiday Bike Ride in December, and Fourth of July bike parade.
