4. APPROVAL OF MINUTES

Vice-Chair Ralph Taboada moved to approve the November 7, 2018 meeting minutes. Member Alan Engard seconded the motion. The motion passed unanimously.

5. OLD BUSINESS

a. Mobility Share Update

Chamber of Commerce Liaison Brent Stoll continued to meet with stakeholders. Brent Stoll shared statistics from the City of Austin's Dockless Mobility Pilot. He also shared the results of a case study on Portland, Oregon's e-scooter pilot program, published by the Portland Bureau of Transportation. Jennifer Rosales, Transportation Services Manager, discussed the City of Santa Ana's upcoming pilot program.

6. NEW BUSINESS

a. West 19th Street Bicycle Project

Raja Sethuraman, Public Services Director opened the item for discussion and gave the committee a brief background of the project. Jennifer Rosales, Transportation Services Manager, presented the proposed project design concept. Staff answered committee member's questions regarding the project. The committee was invited to the project's public meeting on January 17, 2019.

b. Merrimac Way Project

Jennifer Rosales, Transportation Services Manager, gave a presentation on the proposed design concept of the project. Staff is actively seeking grant funding opportunities for the construction phase of the project. The committee was invited to the project's public meeting on January 31, 2019.

c. Proposed Vacation of Excess Right-of-Way at 227 E. 22nd Street

Jennifer Rosales, Transportation Services Manager, presented the item to the committee. Committee members discussed the item.

1. Mark Cernicki, resident of 227 E. 22nd Street spoke in support of the vacation of excess right-of-way.

Vice-Chair Ralph Taboada moved to approve the 5' vacation of excess right-of-way and retain 5' for future bicycle facilities. Member Alan Engard seconded the motion. The motion passed unanimously.

d. Class III Bicycle Projects Prioritization

Jennifer Rosales, Transportation Services Manager, opened the item for discussion. She thanked the committee for taking the web survey and shared the results. Staff will move forward with the committee's recommendations for prioritization.

e. Implementation of Award Levels – HEAL Resolution

Chair Cynthia McDonald discussed the HEAL Resolution and asked the committee to review and provide feedback on the sample resolution. Member James Kane provided some examples of actions that can help the City achieve at least two award levels.

f. Caltrans Grant - Bicycle Racks

Jennifer Rosales, Transportation Services Manager, discussed the project and grant funding. The grant is for \$34,000 to install bike racks at seven locations. City staff can request Caltran's approval of additional locations and racks in public right-of-way with grant funds.
