Perkins and carried 5-0 to recommend to City Council that first reading be given to the ordinance.

The Chair opened the public hearing for consideration of Parcel Map PM-05-292 for Development Company, to subdivide an existing industrial building for condominium purposes, located at 3185-3189 Pullman Street, in an MP zone. Environmental determination: exempt.

Associate Planner Wendy Shih reviewed the information in the staff report and gave a presentation. She said staff was recommending approval by adoption of Planning Commission resolution, subject to conditions. She said staff has included a condition that requires the CC&R's to be revised and recorded prior to the final map recordation to ensure shared parking and access within the common lots.

Rene Varga, authorized agent with Development Resource Consultants, Inc., 8175 East Kaiser Boulevard, Anaheim, agreed to the conditions of approval. He thanked the Commission for considering this item and said he would answer any questions they might have.

Farhsod Abdulahi asked for the record, how the CC&R condition would read because he did not hear it. The Chair directed Mr. Abdulahi to page 7 of the staff report. In further response to the Chair, Ms. Shih explained that the CC&R's are already recorded for common maintenance of the driveways, parking areas, as well as allowance of shared access between the lots. Since this is another parcel map, in addition to the previous one, staff is requiring the CC&R's be revised so everyone is in agreement with maintaining the common area.

No one else wished to speak and the Chair closed the public hearing.

A motion was made by Commissioner Fisler, seconded by Vice Chair Donn Hall, and carried 5-0 to approve by adoption of Planning Commission Resolution PC-06-07, based on analysis and information contained in the Planning Division staff report, and findings contained in exhibit "A", subject to conditions in exhibit "B."

The Chair explained the appeal process.
