REGULAR MEETING OF THE CITY OF COSTA MESA PLANNING COMMISSION August 10, 2009

The Planning Commission of the City of Costa Mesa, California, met in regular session at 6:00 p.m., August 10, 2009, at City Hall, 77 Fair Drive, Costa Mesa, California. The meeting was called to order by Chairman Righeimer.

I. PLEDGE OF ALLEGIANCE TO THE FLAG.

III. PUBLIC COMMENTS:

Chris McEvoy, Costa Mesa, commended Commissioner McCarthy for his comments at the July 21, 2009 City Council meeting relating to high density housing. Mr. McEvoy also voiced his concern that the density of the Westside and the City should not be increased.

The Chair pointed out that at 6:30 p.m. the Commission will be adjourning to a Study Session-Training Session. He asked if anyone wished to make public comments at this time and there was no response.

IV. PLANNING COMMISSIONER COMMENTS AND SUGGESTIONS:

Commissioner Mensinger made a PowerPoint presentation on the renovation of Estancia High School's Football Training Center and invited everyone to attend the Grand Opening on August 20, 2009 at 5:30 p.m. He announced that Pop Warner Football started two weeks ago and the first scrimmages will be on Wednesday night, August 12, 2009, and this Saturday, August 15, 2009. He invited everyone to attend Estancia's Jim Scott Stadium to watch the scrimmages. He also explained about the mentoring program involving high school boys in Costa Mesa instilling football values to the younger boys.

Commissioner McCarthy commented on the Orange County Fair and the National

Night Out Against Crime event last Tuesday. He also expressed concern regarding delays in building construction at various property sites and construction hours on Sundays and construction noise related to absent homeowners.

Vice Chair Fisler confirmed with Assistant Planning Commission Secretary Claire Flynn that minimum work space is reflected in Table A2 (Live/Work Development Standards) of the revised Mesa West Bluffs Urban Plan and positively commented on the addition of minimum work space.

The Chair pointed out that the State has put the Orange County Fairgrounds up for sale. He said this property has a general plan and zoning for fairground use, and the value of the property is based on what it is zoned for. He explained that a non-profit group could purchase this property and keep it as it is now, but any change to the property use would have to be approved by both the Planning Commission and the City Council. He also wished his wife a happy birthday.

Assistant Planning Commission Secretary Claire Flynn reviewed the information in the staff report and responded to a question from the Commission regarding the length of time involved in initiating a Zoning Code amendment. Deputy City Attorney Christian Bettenhausen suggested making a finding pursuant to the existing provisions of the Zoning Code and the Chair and Mr. Bettenhausen discussed the intent of Code Section 13-118.1(a). In addition, Ms. Flynn and Mr. Bettenhausen responded to questions from the Commission regarding the origin and actual language of Code Section 13-118.1, and how to present a finding in the motion so that Group 3 users may apply for temporary sign or banner permits under the existing provisions of the Code.

No one else wished to speak and the Chair closed the public hearing.

MOTION: 1. Direct staff to prepare a Zoning Code amendment to clearly allow Group 3 users to apply for temporary sign or banner permits on

public property and/or public baseball/softball/soccer fields.

2. Make a finding pursuant to Title 13, Sections 13-118.1, 13-118.1A, and 13-118.2 of the CMMC that Group 3 users can apply for temporary sign(s) or banners on public property, pending consideration of a Zoning Code Amendment.
