

**AMENDMENT NUMBER THREE
TO PROFESSIONAL SERVICES AGREEMENT
WITH
ECKERSALL, LLC**

This Amendment Number Three ("Amendment") is made and entered into as of the 15th day of May, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and ECKERSALL, LLC, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on May 16, 2017 for Consultant to provide geographic information system (GIS) consulting services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the term of the Agreement for three (3) additional one (1) year periods; and

WHEREAS, on May 15, 2018, City and Consultant extended the term of the Agreement through May 15, 2019; and

WHEREAS, on May 1, 2019, City and Consultant extended the term of the Agreement through May 15, 2020; and

WHEREAS, City and Consultant now desire to extend the term for one (1) additional year, through May 15, 2021; and

WHEREAS, City and Consultant desire to set forth Consultant's compensation for the extended period.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through May 15, 2021.
2. For the period commencing May 16, 2020 and ending May 15, 2021, Consultant's compensation shall not exceed Forty-Nine Thousand Nine Hundred Fifty Dollars (\$49,950.00). Consultant shall be paid in accordance with the fee schedule set forth in Exhibit "A," attached hereto and incorporated herein by this reference.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
