

**AMENDMENT NUMBER TWO
TO PROFESSIONAL SERVICES AGREEMENT
WITH
HINDERLITER, DE LLAMAS & ASSOCIATES**

This Amendment Number Two ("Amendment") is made and entered into as of the 30th day of June, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and HINDERLITER, DE LLAMAS & ASSOCIATES, a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on April 25, 2018 for Consultant to provide cannabis consulting services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term ending April 24, 2019, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, on April 24, 2019, City and Consultant amended Section 4.1 of the Agreement and extended the term through June 30, 2020; and

WHEREAS, Consultant has continued to provide the services set forth in the Agreement; and

WHEREAS, City and Consultant intend and desire to have this Amendment be effective retroactive to the Effective Date; and

WHEREAS, City and Consultant desire to extend the term for one (1) additional year, through June 30, 2021.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Effective Date.
2. The term of the Agreement shall be extended through June 30, 2021.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.


