4. OLD BUSINESS

- A. Arts and Culture Master Plan
 - 1. Staff informed the Committee that they are locating viable funding options to support the plan's goals before it is taken to City Council for adoption later this year.

1. Tracy informed the Committee that Estancia High School has been confirmed as the next featured Youth Art Gallery exhibit. Tracy reminded everyone that SOY's YAG reception will be held on February 25 from 5-6 p.m.

Art on the Fifth

 Charlene informed the Committee that the reception for Barbara Owens would be held on February 25 from 5-6 p.m. Additionally, she informed the Committee that Jesse Fortune would be the next featured artist.

"The Exhibit" at the Senior Center

1. Charlene informed the Committee Kathie Warren's reception was held on February 10. The next featured *Exhibit* artist will be Alice Leggett.

C. Directory of the Arts

1. Jason thanked Tracy and Frank for their applications and informed the Committee that there are 63 artists and 22 art organizations currently on the directory.

D. Utility Box Art Program

- Frank presented an application from the Historical Preservation Committee to the Committee. Daniel made a motion to approve the artwork and have it installed on Harbor Boulevard and Merrimac Way; seconded by Tracy; the vote passed unanimously.

 - i. Kisma K. Stepanich-Reiding's grant for her Studio Inspiration Art Journal event was presented again due to the Committee's request for additional information regarding the event. Daniel made a motion to approve a \$250 grant; Tracy seconded; the vote passed unanimously.
 - ii. Pacific Chorale requested a \$500 grant for supplies for their afterschool choir program. Debrianna made a motion to approve the \$500 grant; seconded by Tracy; the vote passed unanimously.
 - iii. Nina Gortinski requested a \$500 grant to fund her documentary about sleep patterns. Jason made a motion to decline funds to Nina Gortinski; seconded by Tony; the vote passed unanimously.
 - iv. Orange Coast Unitarian Universalist Church requested a \$500 grant to subsidize the cost of children's tickets for their Orange Coast Film Festival in Costa Mesa. Tony made a motion to approve the \$500 grant; seconded by Jason; the vote passed unanimously.
 - v. Someone Cares Soup Kitchen requested \$3000, to fund a mural project and reception at their facility. Daniel made a motion to approve funding for \$500 with the contingency that they have a design and a plan to fund the rest of the project; Tracy seconded; the vote passed unanimously.
 - vi. Orange Coast College Chamber Singers requested a \$500 grant to assist in travel expenses to Gallo Center. Tony made a motion to approve the \$500 grant; Charlene seconded; the vote passed unanimously.

1. Daniel announced the subcommittee is in the process of finalizing the Call for Artists and will be creating a marketing plan and special job list.
