## **COMMISSIONER COMMENTS AND SUGGESTIONS:**

Commissioner Russell spoke about a demonstration at Triangle Square she attended and about how the City Council and staff have a commitment to both social justice and free speech; on current legislation about having a national police misconduct registry; and read a quote from Harley Rouda.

Commissioner Zich spoke on how it is the time to listen and not debate.

Commissioner Tourje spoke on protest she attended over the weekend; on gentrification; that we do not confront the history of racial segregation that is built into City's policies; racial inequality and how it relates to Planning Commission; and how zoning historically has put segregation into policy.

Commissioner Colbert talked about fighting against racism; an experience he had with the Costa Mesa Police Department while exercising; explicit bias; need to use our powers to create

solutions; spoke on how he is committed to build a better community that serves us all in an equable manner; and recommended books by Ibram Kendi and Richard Rothstein.

Commissioner Perkins spoke on how he would like to form a subcommittee of Planning Commission to immediately investigate how systemic and inequality is integrated into the City Planning Commission related policies, procedures, and codes with a mandate to do public outreach and come up with concrete solutions that could be proposed to City Council or at the public at an election to work towards rectifying racial, economic, and other forms of inequality in the City that are related to Planning Commission topics. He would like to agendize this topic at the next meeting.

Vice Chair Harlan spoke on how the City has people who are committed and passionate that want to see justice and the City budget is an important policy document that sets the standards for moving forward in years to come.

Chair de Arakal spoke about racism in our country; supports that the City laws are written in a way for equal justice for all; supports Commissioner Perkins request for a subcommittee; commended the way the City's Police Department handle the recent protest in the City; and spoke on housing equal opportunity for all people that reside in the City.

Mr. Curtis explained the process of forming a subcommittee.

Chair de Arakal and Mr. Curtis discussed that the subcommittee could be considered at the next meeting.

# **PUBLIC HEARINGS**

1. PLANNING APPLICATION 20-03, A CONDITIONAL USE PERMIT TO ALLOW AN EXISTING SERVICE STATION AND MINI-MARKET (CHEVRON/EXTRA MILE) TO OPERATE UNDER A STATE ALCOHOLIC BEVERAGE CONTROL LICENSE TYPE 20 (OFF-SALE BEER AND WINE) CONCURRENT WITH THE SALE OF MOTOR VEHICLE FUEL WITH A FINDING OF PUBLIC CONVENIENCE OR NECESSITY AT 3000 FAIRVIEW ROAD

**Project Description:** Planning Application 20-03 is a request for a Conditional Use Permit to allow the sale of alcoholic beverages for off-site consumption pursuant to a State Alcohol and Beverage Control (ABC) License Type 20 (Off-Sale Beer and Wine) in conjunction with the sale of motor fuel for an existing service station and mini-market (Chevron) located at 3000 Fairview Road. The applicant is also requesting a Finding of Public Convenience or Necessity (PCN) pursuant to State ABC regulations. The sale of beer and wine is proposed between the hours of 6 AM to 12 midnight daily (the existing service station is open 24 hours).

**Environmental Determination:** The project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15301 (Class 1), Existing Facilities.

No ex-parte communications to report.

Mel Lee, Senior Planner, presented the staff report and stated that two correspondences were received this afternoon, one for the project and one opposed to the project.

Discussion with Commission and staff ensued on if the application has to have both finding and necessity of public convenience; the current over concentration of off-sale licenses in the census tract and the reason why an additional license cannot be added; code enforcement issues; why the original application in 1998 was denied; when other off-sale licenses in the census tract were acquired; similar potential applications for alcohol sales in this area; whether there were any community impacts in the area from the businesses with off-sale licenses; noticing requirements for this type of application and how many notices were mailed out; census tract map for the area that shows the location of existing ABC licenses; Condition of Approval No. 3 - that the applicant will need to purchase a Type 20 ABC license from an over concentrated census tract; the potential hazardous waste in the area had been mediated; Type 20 ABC license associated with the Wild Water car wash; this application getting an ABC license is contingent on acquiring one from a business in the census tract that has an existing license; and the conditional use permit will be valid for two years;

## **PUBLIC COMMENTS**

Mr. Rawlings stated that he has read and agrees with the conditions of approval and responded to Commissioner's questions.

Discussion with the Commission and applicants ensued on whether the applicant has identified another business that will transfer their ABC license; what is the convenience and necessity requirement or an ABC license; any signage or promotion of the products will occur; and Chair de Arakal stated that he wants the conditions to specify including interior and external surveillance system.

- 3. If the Planning Commission determines that a PCN finding is appropriate, adopt a Resolution to approve Planning Application 20-03, subject to conditions of approval with the following revised condition.

#### **REVISED CONDITIONS:**

Condition of Approval No. 12: Operator shall provide 24-hour security camera surveillance of the interior of the building and the exterior, including the parking area and service station pumps, capable of archiving a minimum of 30 days of stored video footage, made available to the Costa Mesa Police Department upon demand.
