

**AMENDMENT NUMBER TWO
TO PROFESSIONAL SERVICES AGREEMENT
WITH
DENNIS GRUBB & ASSOCIATES LLC**

This Amendment Number Two ("Amendment") is made and entered into as of the 6th day of November, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and DENNIS GRUBB & ASSOCIATES LLC, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on November 7, 2018 for Consultant to provide plan review services for the Fire Department (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, on November 6, 2019, City and Consultant extended the term through November 6, 2020; and

WHEREAS, City and Consultant now desire to extend the term of the Agreement for one (1) additional year, through November 6, 2021; and

WHEREAS, City and Consultant desire to set forth Consultant's compensation for the extended period accordingly; and

WHEREAS, City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Effective Date.
2. The term of the Agreement shall be extended through November 6, 2021.
3. For the period commencing November 7, 2020 and ending November 6, 2021, Consultant's total compensation shall not exceed Forty-Nine Thousand Nine Hundred Ninety-Nine Dollars (\$49,999.00).
4. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
5. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.






