## **PUBLIC HEARINGS**

# 1. ZONING APPLICATION 20-17 FOR A MODIFIED PLANNED SIGNING PROGRAM FOR RANDY'S DONUTS AT 2930 HARBOR BOULEVARD

**Project Description:** Zoning Application 20-17 is a request for a Planned Signing Program for Randy's Donuts to allow for one roof mounted sign in the form of a donut with exterior illumination to be located at the front of the building. The sign will be approximately 433 square feet and total height is 39 feet 11 inches above finished grade. One illuminated wall sign mounted above the entrance to the restaurant on the south side of the building and one freestanding directional sign at the driveway entrance are also proposed. A previous iteration of the application was conditionally approved by the Planning Commission at the October 12, 2020 meeting.

**Environmental Determination:** The project is categorically exempt from the provisions of the California Environmental Quality Act (CEQA) per CEQA Guidelines Section 15311 (Class 11), Accessory Structures.

Ms. Colgan stated that one public comment had been provided to the Commission and made a part of the record.

Commissioner Perkins recused himself at 6:26 PM due to living within close proximity of the project location.

No ex-parte communications to report.

Chris Yeager, Assistant Planner, presented the staff report.

Discussion with Commission and staff ensued on the size of the donut shaped sign in the illustrated in the southbound Harbor Boulevard rendition. The applicant was asked a question regarding the lighting.
