# 6. Commissioner Comments

Commissioner Ashendorf - Happy to be back and working. Wants to thank Senior Center staff for coordinating a wealth of partnerships to secure meals for the last quarter and several thousand phone calls to the Senior members. Thanked Chair Erickson and wife Michelle for coordinating cards for Seniors with the PTA at Victoria Elementary School. Is looking forward to Perez Park's opening.

Commissioner Frager - The Segerstrom Center has musical theater classes running soon and registration for these classes begin February 9<sup>th</sup> for a 5 class virtual series ages 9-18. Have been holding dance and fitness down in the plaza. Pacific Chorale has been running their program for their elementary school aged children through March. Pacific Symphony elementary school program will be up and running soon. Thanked the City and said her Goodbyes.

Vice Chair McNabb - Thanked Ms. Frager for her dedication to the City. Thanked City staff for the successful blood drive at the Senior Center. Very excited for Perez Parks opening. We should soon see the Orange County Fairgrounds be a vaccination site. Looking forward to that service be available. #### 9. New Business

a) Tree Removal Request - 1777 Bahama Place

Mr. Robert Ryan, Acting Maintenance Superintendent presented.

#### Comments:

Alyssa Dobrott (Public) - Concerned about how invasive the tree is to the property and wants to replace the tree with a less invasive root system.

John Dobrott (Public) - seconded what Alyssa spoke about.

Chair Erickson asked if any root trimming has happened to helped mitigate the risk for the property.

Mr. Ryan said not at this time due to the way the tree stands.

Commissioner Ashendorf asked if the synthetic turf something the home owner did or the City?

Mr. Ryan said it was the homeowner.

Commissioner Ashendorf asked when was the last trimming for the tree was.

Mr. Ryan said the typical "trimming cycle" is somewhere between 3-5 years, so anytime between now and 2023.

Chair Erickson mentioned that a potential option for the homeowner could be a category III tree removal where the homeowner replaces the tree in a 3:1 ratio, so will not approve the motion.

b) Tree Removal Request - 877 Sonora Road

Mr. Robert Ryan, Acting Maintenance Superintendent presented.

#### Comments:

Manfred Freeberger (Public) - It's not so much the leaves, it's on a permanent basis and he's 68 and retired and tired of having to constantly cleaning.

Vice Chair McNabb asked if a pruning can get scheduled.

Mr. Ryan anticipates within the 6-9 months

Mr. Freeberger spoke about a conversation with City Arborist, Jim Ortiz, and mentioned that the tree is not a seasonal drop but a constant drop.

Chair Erickson asked how are the other trees on the block? Do others exhibit this issue?

Mr. Ryan mentioned that no other complaints have been received the area about the trees and that other trees have not exhibited excessive droppings.

Commissioner Rutherford found the request invaluable and is against killing a healthy tree and do not see how a motion can go forward to remove the tree.

Chair Erickson requests staff to have this location be a priority for a tree trimming.

Mr. Ryan explained that the City owned areas does not fall in the area that is uplifting.

Commissioner Ashendorf inquired about the height and power lines. Mr. Ryan addressed that Edison will usually come and trim any trees that may interfere with power lines.

Mr. Loyd rescinded his request after understanding more of the procedures.

Mr. Minter requested for contact information, so we can find that answer, since the Police Department is not on this call.

Commissioner Rutherford wanted a follow-up to Mr. Ibarra's question, since in the past I have been concerned with citations being issued without knowledge of the code. Educating the public is the first approach before citing.
