Grants must be requested in even amounts. Typically, we use \$45,000 to run the Concerts yearly.

They are asking for \$2,000 to help students that are dealing with homelessness. They will utilize the grant to help pay for the school supplies, food, and utility costs.

Summary	The Arts & Learning Conservatory will be providing a virtual, musical theater class for 45-50 low-income, and predominantly minority youth at Adams Elementary, grades 4-6. The project will occur 2 hours a session for 12 weeks, January – April 2021. The Arts & Learning Conservatory is asking for \$4,500 which will cover the cost to produce and includes scripts/royalties, professional instruction for 45-50 and includes costumes, along with professional videography and editing. Adams Elementary was able to raise and match \$900 with the dedication of families who value the benefits of what theater brings to their children.,
