#### 8. OLD BUSINESS

a) 2022 Goals

Ms. Torrejon presented the proposed Committee goals.

Parks and Community Services Director Jason Minter suggested for the committee to set measurable goals and to narrow them down and make them more specific.

General discussion ensued regarding proposed Committee goals.

The following goals resulted from the discussion:

- 1. Making recommendations regarding release of live animals within City Limits ordinances to City Council.
- 2. Produce public service announcements, in print and in video, related to the three-pronged partnership with Animal Control, Newport Center Animal Hospital, and Priceless Pet Rescue to strengthen public awareness and confidence of animal services. Strengthening relationship between public and Animal Control.
- 3. Promote and implement the Pet Financial Assistance Program by obtaining funds through Community partnerships, grants, and donations.
- 4. Educate the public on responsible pet ownership and care no less than six times per year and through avenues such as, special events, The Scoop, City events and provide ongoing resources regarding animal shelter and adoption services.
- 5. Review other City regulations for beekeeping.

# b) Working Groups – Update

Committee Member Minjares inquired about meeting more often to ensure the committee has a clear vision and preferring to receive the action plan before the meeting.

a) TNR Research - Trap, Neuter, Release

Ms. Torrejon recommended for the Committee to work collectively on the TNR (Trap, Neuter, Release) and live animal release ordinance items during Committee meetings. An action plan will be created to help delegate tasks to prepare their recommendation to City Council.

### 10. FINAL REPORTS AND COMMENTS

Council Member Gameros mentioned that the animal transfers need to be fixed and Newport Center Animal Hospital should be providing medical paperwork to Priceless Pet Rescue.

Chair Walls stated that behavioral records should also be disclosed on paperwork.

Committee Member Minjares agreed that documentation needs to be fixed.

Mayor John Stephens thanked the Committee for their service.
