AMENDMENT NUMBER THREE TO PROFESSIONAL SERVICES AGREEMENT WITH ATLAS PLANNING SOLUTIONS

This Amendment Number Three ("Amendment") is made and entered into this 17th day of February, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and ATLAS PLANNING SOLUTIONS, a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on February 17, 2020 for Consultant to assist with the development of a Local Hazard Mitigation Plan for the City (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, due to the COVID-19 pandemic, the development of the Local Hazard Mitigation Plan has taken more time than initially contemplated; and

WHEREAS, City and Consultant extended the term through February 16, 2022 through Amendment Number One to the Agreement on February 16, 2021; and

WHEREAS, City and Consultant further extended the term Through February 16, 2023 through Amendment Number Two to the Agreement on February 16, 2022; and

WHEREAS, City and Consultant now desire to extend the term for one (1) year, through February 16, 2024.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The term of the Agreement shall be extended through February 16, 2024.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 3. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
