AMENDMENT NUMBER FOUR TO PROFESSIONAL SERVICES AGREEMENT WITH TILLMAN FORENSIC INVESTIGATIONS LLC

This Amendment Number Four ("Amendment") is made and entered into this 1st day of February 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and TILLMAN FORENSIC INVESTIGATIONS LLC, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on February 1, 2019 for Consultant to provide latent fingerprint examination and verification services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, on December 30, 2019, City and Consultant extended the term for one (1) additional year, through January 31, 2022; and

WHEREAS, on January 31, 2022, City and Consultant amended Section 4.1 of the Agreement to provide the option to extend the term for two (2) additional one (1) year periods, such that the Agreement may be extended by a total of four (4) additional one (1) year periods; and

WHEREAS, on January 31, 2022, City and Consultant also extended the term through January 31, 2023, amended Consultant's fee schedule and increased the annual compensation accordingly; and

WHEREAS, City and Consultant desire to extend the term for one (1) year, through January 31, 2024.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- The term of the Agreement shall be extended through January 31, 2024.
- All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
