

**AMENDMENT NUMBER SEVEN  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
AGA ENGINEERS, INC.**

This Amendment Number Seven ("Amendment") is made and entered into this day of January 2, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and AGA ENGINEERS, INC, a California corporation ("Consultant").

WHEREAS, City and Albert Grover & Associates, Inc. entered into an agreement on January 3, 2018 for Albert Grover & Associates, Inc. to provide traffic and transportation engineering consulting services in connection with the Interstate 405 (I-405) Improvement Project (the "Agreement"); and

WHEREAS, City and Albert Grover & Associates, Inc. amended the Agreement to increase Albert Grover & Associates, Inc's maximum compensation to Eighty-Four Thousand Nine Hundred Ninety-Nine Dollars (\$84,999.00) through Amendment Number One to the Agreement, dated January 15, 2019; and

WHEREAS, City and Consultant amended the Agreement to reflect the assignment of the Agreement from Albert Grover & Associates, Inc. to Consultant through Amendment Number Two to the Agreement, dated September 3, 2020; and

WHEREAS, Section 4.1 of the Agreement provides for a term of three (3) years, with the option to extend the term for two (2) additional one (1) year periods; and

WHEREAS, City and Consultant extended the term of the Agreement for one (1) year, through January 2, 2022, through Amendment Number Three to the Agreement, dated January 2, 2021; and

WHEREAS, City increased Consultant's maximum compensation to One Hundred Nine Thousand Nine Hundred Ninety-Nine Dollars (\$109,999.00) to enable City to use Consultant for additional traffic and transportation engineering consulting services through Amendment Number Four to the Agreement, dated February 16, 2021; and

WHEREAS, City increased Consultant's maximum compensation to One Hundred Nine Thousand Nine Hundred Ninety-Nine Dollars (\$109,999.00) to enable City to use Consultant for additional traffic and transportation engineering consulting services through Amendment Number Four to the Agreement, dated February 16, 2021; and

WHEREAS, City increased Consultant's maximum compensation to One-Hundred Thirty-Four Thousand Nine Hundred Ninety Nine Dollars (\$134,999.00) to enable City to use Consultant for additional traffic and transportation engineering consulting services in connection with the I-405 Improvement Project through Amendment Number Five to the Agreement, dated September 7, 2021; and

WHEREAS, City and Consultant extended the term of the Agreement for one (1) year, through January 2, 2023, through Amendment Number Six to the Agreement, dated January 2, 2022; and

WHEREAS, City and Consultant now desire to extend the Agreement for six (6) additional months, through June 30, 2023.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through June 30, 2023.
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


