

**AMENDMENT NUMBER ONE  
TO PUBLIC WORKS AGREEMENT  
BETWEEN  
THE CITY OF COSTA MESA  
AND  
WILLIAMS SCOTSMAN, INC**

This Amendment Number One ("Amendment") to Public Works Agreement is made and entered into this 18<sup>th</sup> day of May, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("Lessee") and WILLIAMS SCOTSMAN, INC ("Lessor").

WHEREAS, Lessee and Lessor entered into a public works agreement on August 30, 2021, for the removal of an office trailer (the "Agreement"); and

WHEREAS, Contractor and City have determined that removal of the trailer will require additional services; and

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Lease as follows:

1. Section 7 of the Agreement is amended to increase the total compensation paid to Contractor by Six Hundred and Fifty Dollars (\$650.00) for the provision of one time additional services related to the removal of the trailer.
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one Agreement together with this Amendment Number Two and Amendment Number One.


