

**AMENDMENT ONE TO
PROFESSIONAL SERVICES AGREEMENT
WITH
DAVID EVANS AND ASSOCIATES, INC.**

This Amendment One ("Amendment") is made and entered into as of 25th day of May, 2023 ("Effective Date"), by and among the CITY OF COSTA MESA, a municipal corporation ("City") and DAVID EVANS AND ASSOCIATES, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into a professional services agreement dated September 21, 2022 for design services for raised crosswalks and bulb-outs (the "Agreement"); and

WHEREAS, City and Consultant desire Consultant to provide additional work as outlined in Consultant's proposal.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement is amended to add to the Scope of Services the services more specifically described in Exhibit A to this Amendment.
2. Commencing on the Effective Date of this Amendment, Section 2.1 of the Agreement is amended to increase Contractor's compensation to Thirty One Thousand Five Hundred Fifty Five Dollars (\$31,555.00).
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one Agreement together with this Amendment Number Two and Amendment Number One.



**Subject: Change Order #1 Proposal for Civil Engineering Services for
Pomona/Sterling Intersection Raised Crosswalk**

Dear Ramin:

Our original scope of work included the development of construction documents for three locations based on concept plans the City provided for Meyer Place/Surf Street, Meyer Place/Bay Street, and Pomona Avenue/Sterling Avenue. The latter location has design concerns due to the proximity of driveways and as such, the City has requested alternatives to be examined which has resulted in additional conceptual design work and meetings with the City. The latest directive from the City of Costa Mesa is to change the design from the original concept at Pomona and Sterling Intersection to be a fully raised crosswalk on both sides of the street, with a bulb-out on Sterling Avenue. The initial directive was to proceed with the concept design which had a raised crosswalk flush with the curb on the east and a slope down to the cross gutter on the west. With the new alternatives and design we were requested to develop and the additional meetings we have held, a change order to our original scope is needed.

Additional tasks to our original scope include:

- Additional meetings – we budgeted for one meeting, and we’ve had five (5) total to date
- Re-design of Pomona and Sterling intersection raised crosswalk, adding a bulb-out, and ADA ramp reconstruction
- Updating horizontal control and detail sheets due to the re-design
- Evaluation of alternatives at Pomona and Sterling intersection

We estimate an additional fee of **\$6,655** for the additional work described per the fee breakdown below:

Meetings & Coordination	\$1,660
Re-design of Pomona/Sterling raised crosswalk	\$2,820
Horizontal Control & Details sheet updates	\$1,240
Evaluation of Alternatives	\$935
Task Subtotal	\$6,655

The following items are excluded from our scope of work:

- Utility research and coordination
- Traffic signal modification
- Separate grading plan title sheet
- Drainage study
- Signing & striping Plan
- Landscape and Irrigation design
- Lighting design
- Plan check and permit fees

If you have any questions, please let us know, otherwise please sign and return the attached Addendum Agreement Change Order #1 as soon as possible and we will proceed with the revised scope.
