

**AMENDMENT NUMBER FIVE TO  
PROFESSIONAL SERVICES AGREEMENT  
WITH  
PRICELESS PUPPY RESCUE, CORP**

This Amendment Number Five ("Amendment") to Professional Services Agreement is made and entered into this 23<sup>th</sup> day of June, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and PRICELESS PUPPY RESCUE, Corp, a California nonprofit dba PRICELESS PET RESCUE ("Contractor").

WHEREAS, City and Contractor entered into an agreement on January 22, 2018, for Contractor to provide animal adoption services (the "Agreement"); and

WHEREAS, on June 6, 2018, the parties executed Amendment Number One extending the term of the Agreement through January 1, 2019, and providing compensation accordingly; and

WHEREAS, on October 3, 2018, the parties executed Amendment Number Two increasing Contractor's maximum compensation; and

WHEREAS, April 16, 2019, the parties executed Amendment Number Three amending the scope of services, extending the term through June 30, 2021, and updating the compensation; and

WHEREAS, on May 20, 2021, the parties executed Amendment Number Four extending the term through June 30, 2023, and increasing the scope of services; and

WHEREAS, City and Contractor now desire to extend the term of the Agreement for one month and thereafter automatic extensions of one month each, while city solicits new Proposals for the Scope of Services.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Lease as follows:

1. Section 4.1 of the Agreement is amended to provide that commencing on July 1, 2023, the term of the Agreement is extended for one month expiring on July 31, 2023. Thereafter, the agreement shall automatically renew for successive one month periods, unless either party provides written notice of termination or non-renewal prior to the renewal date.
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall

constitute one Agreement together with the Agreement, Amendment Number One, Amendment Number Two, and this Amendment.
