AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH

LG2WB ENGINEERS, INC. DBA LINSCOTT, LAW & GREENSPAN, ENGINEERS

This Amendment Number Two ("Amendment") to Professional Services Agreement is made and entered into this 26th day of June, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and LG2WB ENGINEERS, INC., a California corporation dba Linscott, Law & Greenspan, Engineers ("Consultant").

WHEREAS, City and Consultant entered into an agreement dated June 14, 2021, for the provision of traffic engineering design services in connection with a new traffic signal at the intersection of West 19th Street and Wallace Avenue (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one year, with the option to extend the Agreement for two additional one year periods; and

WHEREAS, on June 1, 2022, City and Consultant exercised the first of two options to extend the term through June 1, 2023, through Amendment Number One; and

WHEREAS, City and Consultant now desire to exercise the second and final option to extend the term.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Lease as follows:

- 1. The term of the Agreement shall be extended through June 13, 2024.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one Agreement together with this Amendment, Amendment Number One, and the Agreement.
