AMENDMENT NUMBER THREE TO PROFESSIONAL SERVICES AGREEMENT WITH KEYSER MARSTON ASSOCIATES, INC.

This Amendment Number Three ("Amendment") is made and entered into this 1st day of September, 2023 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and KEYSER MARSTON ASSOCIATES, INC, a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on February 8, 2021, for Consultant assist the city in creating an inclusionary housing program (the "Agreement"); and

WHEREAS, City and Consultant extended the term of the Agreement through execuction of Amendment Number One on February 8, 2023; and

WHEREAS, on April 4, 2023, City and Consultant executed Amendment Number Two increasing Consultant's maximum compensation; and

WHEREAS, City and Consultant now desire to increase Consultant's maximum compensation by \$30,000 for completion of the project.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as follows:

- 1. Section 2.1 of the Agreement is amended to increase Consultant's maximum compensation by \$30,000.00. Consultant's total compensation shall not exceed a total amount of \$100,000.00.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
- 3. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and the Agreement together with Amendment Number One, Amendment Number Two, and this Amendment shall constitute one Agreement.
